



## SMARTART ROTATION PROGRAM SUBSCRIPTION AGREEMENT

IN CONSIDERATION OF the terms and conditions hereafter expressed, this Subscription Agreement ('Agreement') is made effective as of the date set forth below between **Corporate Art Force, LLC dba Art Force**, 1400 Van Buren Street N.E., Suite 175, Minneapolis, Minnesota 55413 and \_\_\_\_\_.

### TERMS AND CONDITIONS.

1. Your SmartArt Rotation Program Subscription is pending credit approval.
2. Details of the art selection and subscription term and amounts are attached as Exhibit A as part of this Subscription Agreement.
3. The subscription fees shall be paid monthly in advance by Credit Card or ACH.
4. In the event of a 30 day free trial the subscription fees shall begin after 30 days.
5. Your subscription term shall not be less than twelve (12) months. At the end of the term the subscription shall continue month to month until a renewal agreement or cancellation in writing.
6. You agree to keep the artwork in as good a condition as on the date of delivery.
7. You will not photograph, sketch, or otherwise reproduce the artwork.
8. You are liable for any loss or damage of the art and will maintain proper insurance coverage.
9. Our representatives may inspect the art at any time with a twenty four (24) hour notice and during business hours of 9:00 AM and 5:00 PM.
10. Applicable state and local taxes are applied to the monthly subscription.
11. You may increase the number of art pieces at any time during the subscription term.
12. You must maintain at least 3 art pieces at all times.
13. You may purchase the art at any time. Financing is available based on credit approval.
14. You have a 1st right of refusal on all outside purchase offers.
15. SmartArt Display Systems and components may be added to your subscription at any time.
16. SmartArt Display Systems, components, installation and shipping fees are calculated separately and can be billed separately or included in the monthly subscription payments.
17. SmartArt Display Systems are used for art exchange convenience and to ensure the security of the art and are not for purchase. Standard fees apply monthly for the first year then reduced to \$1.00 for each month thereafter.
18. Art rotation is available each six (6) months of your subscription. You will be notified in advance of rotation eligibility.
19. You will not remove or move the art without approval from Art Force.
20. Upon default of any or all of the herein, Art Force may at is option take immediate possession of the art work and for such purpose enter premises with a twenty four (24) hour notice and during business hours of 9:00 AM and 5:00 PM. You are responsible for any and all remaining fees associated with the subscription agreement.

This Agreement shall be construed in accordance with the laws of the State of Minnesota.
